## New Business:

Chief Reed said this is to upgrade the radios. It is a state contract and with a discount the cost would actually be \$48,453.78.

Chief Murrell said the funding is there. \$18,000 will come from SPLOST and he will use the money that was donated.

## 5. Second reading of the City of Rincon Capital Cost Recovery Fee Ordinance.

Mayor Lee said after discussion with staff he would like to ask that his be tabled until the next meeting so they can have the time to sit down with the engineers that came up with the fees and get the background on how they came up with the fees.

Councilmember Rahn asked did we pay engineers or did we base it off the City of Savannah. EMC Engineering did this. Councilmember Rahn asked when the last study was done; Attorney Dickey said we will have to ask the engineers.

## 7. Administrative Reports:

**City Manager** – Mr. Stewart said he would like to have a work shop next week about the Growth Management Ordinance. A workshop will be held August 29<sup>th</sup> at City Hall.

**Recreation Dept.** – Mr. Osborne gave Council an update on the rodeo. He said we will be having the rodeo unless we have severe weather and he did purchase the weather insurance; he has the Lewis and Clark Circus locked in for September; they are looking to start on the new park on the 30<sup>th</sup> October;

**Water/Sewer/Public Works** – Councilmember Browher asked about trees on Highway 21 between 5<sup>th</sup> and 6<sup>th</sup> Streets, Mr. Bowles said they are trying to coordinate between tree experts and GDOT.

**Finance** – Mrs. Cartwright informed Council she will be starting on the 2023 budget in September.

**Mayor and Council** – Councilmember Taylor said she would like to put on the workshop agenda getting the fire house built and increasing pay for the firefighters and police officers with the money we are getting from the government. Councilmember Rahn asked about accident near the YMCA, Mr. Bowles said that is a construction entrance, once construction is complete they will not be using it. Councilmember Browher asked about Picket Fences. He said we have to find a solution and he wants staff to come up with some options. Councilmember Scott said we need to sit aside funds and start a dialogue with all involved parties. Councilmember Rahn said we have a lot of things that we have tabled and put on the side is there any way we can put them on a white board to keep us on task. Mr. Stewart said yes. Councilmember Browher said the entrance light at Dashers Landing has been out; Mr. Stewart said he has reached out to Hargray and will try again.

## 6. Public Comments (Limit to five minutes)

One citizen had questions about the annexation request process.

Chief Murrell said he has four positions to fill and has two interested parties that are under 21. He wanted to know from Council if they can hire them. Councilmember Rahn asked the candidate pool, Chief Murrell said they have had one applicant within the past three to four weeks. Councilmember Rahn asked what does he see as the issue, advertisement, Chief Murrell said we are just not getting interest. Councilmember Rahn said money, Chief Murrell said money, we are not competitive with our pay anymore. Councilmember Rahn asked what do you see as the resolution; Chief Murrell said if we can get our pay bumped up, that is not the reason he came up here, but if we can bump our pay up to be competitive, \$21.50ish to \$22.80 an hour. Councilmember Scott said the County raised their pay but they did it during their budget, we are in the budget planning stage. This should be in the budget planning and not here. We all now it is an issue. Chief Murrell said he was able to show on paper where there is savings to the current salary this year because we have been short two employees all year and now we are short four, so there is money to fund that

without having to do a budget amendment. Councilmember Scott said when we approve a budget for the year we should try to work through that budget; he knows that every department needs new employees. Councilmember Rahn said he looks to Council to provide Chief Murrell with what he needs and budgets are made to be amended.

Councilmember Blackwell asked if the new hires will be with a senior office the whole year. Chief Murrell said no, it would be ten to twelve weeks. Mayor Lee asked was there any legal restrictions that would prevent us from doing this, Attorney Dickey said we should check with insurance company.

Councilmember Taylor said rest assured she spoke with the lady at GMA and they said we have money from the government, the Recovery Care Act and she is going to find it and get raises done.

Councilmember Browher asked was there no policy about hiring someone 21 years old, he wants to make sure we are not violating our policy and procedures. Chief Murrell said he couldn't find anything but will check again.

Eddie Coleman said as a citizen he prefers to be taxed fairly on the real estate value of his home as opposed to increase service fees in the City.

Cirincione Bacon stated his position on items 1, 2, and 3. Mr. Bacon said we should have the right to life, liberty and pursuit of happiness. When you rezone this property you will change their way of life. The Council should consider the citizens that were here before.
