This will be one of four tent circus that Lewis and Clark would like to hold at Freedom Park. They are requesting no rental fee and would like to offer a percentage of ticket sales. The City can monitor the ticket sales at the gate, tickets will be sold by the seat and the max capacity for each show is 500 people. Attorney Dickey has the contract ready to sign. This event has been held in other cities without incident and no police presence. The tent will be enclosed with heat and air. They will sell food and have a permit from health department. Lewis and Clark will advertise 2 shows each day on Friday, Saturday and Sunday. Councilmember Browher mentioned the safety of tent structure. Wanda Simmons stated they have a liability certificate of insurance and no alcohol will be sold. A motion was made to approve with a \$500.00 deposit and waive all rental fees in lieu of ticket sales. The dates of the shows will be April 22nd, 23rd and 24th.

8. Administrative Reports:

City Manager – Interim City Manager, Wanda Simmons, informed Council that all the animals have been removed from 118 Fox Trace (nuisance abatement); GA DOT wants motorist to be aware of the nighttime paving on SR 21 between 7th and 4th Streets; the City owes \$43,745.24 to Effingham County BOC for capital cost recovery fees for the months of September – December.

City Engineer – No written report

Chief of Police – Chief Scholl informed Council that five to six people enrolled in the Citizens Police Academy; the wind screen on the fence in the Police department is falling apart, he will look at the cost of different options to replace the screen. Chief Scholl asked Council if he could remove the screen since there is nothing of value in the parking lot, Mayor Lee said it was ok to take it down.

Fire Department –Fire Chief Corey Rahn informed Council the tornado siren were activated for three minutes and worked well; he spoke with EPD about a fuel spill in the ground at 21 Fuel Stop, there was approximately 2,000 gallons spilled since July, Mr. Patel will be billed for all charges related to the spill. The pumps are closed, but the store is open. There will be long term monitoring to make sure it does not happen again.

Building/Zoning Dept. – LaMeisha Kelly gave the 2015 capitol cost recovery report to Council; She informed Council that Blandford Elementary Scholl is having Family Night and is asking for donations, she would like to donate bags for the event.

Water/Sewer/Public Works – Tim Bowles informed Council that they are still working on the water tower; the bull gang is working on the ditches on Scott Ave trying to open them up. They are picking up the inmates used at the facilities with the van and we need a replacement inmate for the Police Department and City Hall.

Wastewater – Tommy Kee informed Council Terracon will be coming out to the treatment plant for soil samples.

Mayor and Council - Mayor Lee discussed the railroad crossing repairs at the entrance of Picket Fences, the residents are having concerns about not being able to get out when the crossing is closed, Council needs to consider trying to resolve issue. Council discussed the house on Williams Street, having inmates clean the yard, paint and do minor repair. Tim Bowles said they could spend a week doing the work. Councilmember Browher stated we could spend \$500.00 to get the house ready to sell.
