Councilmember Scott asked are we paying this quarterly, Wanda Simmons said yes and these payments will bring us to March 2016. Councilmember Browher asked if they were still using their van, as of today yes. Mrs. Simmons said that would change in the next two or three days.

Joseph Palmer was present. LaMeisha Kelly informed Council Mr. Palmer did go before the Planning and Zoning Board. A quorum was not present but approval was recommended.

Kate Busbee was present. She told Council there would be minor road impact, they will have water guns and water hoses along the route and they will use the same route as last year. She has already contacted Lieutenant Ramirez about traffic control.

4. Eva Cross would like to appear before Council to discuss the street conditions on Plantation Way and Plantation Drive.

Mrs. Cross said she has made several phone and written requests for the potholes to be fixed on Plantation Way and Plantation Drive. Mrs. Kelly said the streets are privately owned by a defunct organization and this is a problem. Mrs. Cross said the potholes had been fixed before by the City. Attorney Dickey said the previous City Manager, Wesley Corbitt felt it was an emergency because it was a public safety issue and public works did a quick patch. Councilmember Dasher stated the owner was supposed to turn the streets over to the city. Councilmember Scott explained the process, and informed Ms. Cross we will research who owns the street. Attorney Dickey said the streets were purchased by an inexperienced buyer.

5. Request approval of Georgia Emergency Management Agency- Homeland Security Statewide Mutual Aid and Assistance Agreement.

Clint Hodges, Effingham County interim Emergency Management Director was present. Every county and municipality in the state participates. Councilmember Ricker said we have to have this agreement if we want any help from the state. Mrs. Kelly had concerns about who would be the contact person for public works. Mr. Hodges said the contact is Greg Riles.

6. Move SPLOST monies from Macomber Park line item to Giles Park line item for improvements to Giles Park.

Mrs. Simmons stated the amount that will be moved is \$10,000.000

Mrs. Simmons informed Council the equipment will be ADA accessible. All the equipment she looked at will fit in the park and has been measured and scaled.

Mrs. Simmons said Council has budgeted \$25,000.00 for parks, \$10,000.00 was moved to Giles Park, the \$15000.00 left will cover upgrades to the other parks. Upgrades to Jaycee Veterans Park will include a mother and baby swing, new balance beam, a waist high stove and family size grills. Council discussed a pavilion, removing trees, and adding additional swings.

Tim Baumgartner said the same company did a paving job in his neighborhood and did a good job. Councilmember Dasher stated he would like to see the traffic control breakdown.

Chance Raehn was present; he is purchasing the property from Ameris Bank. Councilmember Ricker asked Attorney Dickey if he thought there was a problem, he said no. There was discussion about Ameris Bank granting access to the Murphy property and Habitat for Humanity.

13B. Discussion of the Golf Course geese issue.

Mrs. Simmons received an email from Mr. Zeigler. He stated there is a limited time window on when someone can come out and remove the geese. The dog is working but baby geese can't fly so he doesn't want to run the dog. The cooperative service agreement will not exceed \$1,017.00. Councilmember Dasher said the geese are shedding wings during month of June; he would like to see us get rid of as many as possible. Al Hicks, a Lost Plantation resident, said it is not as bad as it used to be, he sees a lot less, 15 geese versus 60. Councilmember Browher asked whether they would remove the babies also, Councilmember Dasher said yes.

14. Administrative Reports:

City Manager – Mrs. Simmons reminded Council about the GMA convention in June and the workshop with Mr. Moxley on Thursday at 6:00 PM. Mrs. Simmons read complimentary a letter from Leah Harrison to the Rincon Police Department about and accident on Fort Howard Road.

City Engineer - Alec Metzger gave a update, the Fort Howard Road utility extension bids have been advertised; the 9th Street Water Line project is out to bid; he met with DOT about the sidewalk from Wal-Mart to St. Joseph, the creek was surveyed and he believes they can move the guardrail and make it fit, a head wall may need to be added.

Building/Zoning Dept. – No written report. WTOC came out and talked to Mrs. Kelly about the Hwy 21 improvements; a developer wants to talk to council about project on Ft. Howard Road and Old Augusta Road. Mrs. Kelly will provide a detailed report in June to update Council about Freedom Rings in Rincon.

Water/Sewer/Public Works – Tim Bowles provided a two month written report. Mayor Less asked if he was still under staffed. Mr. Bowles said one was out sick and one may be transferring to WWTP, he will soon to be three under staffed. He has ordered new city flags and decals for the vehicles. The company he ordered from would like to use the Rincon vehicles in their national advertising and he would like Council's permission. The decals are 18" diameter. He also received letter from Richard l. Truluck at 631 Towne Park West Dr condominium; there was a sewer back up on April 13 he met with the owner at the property an opened the manhole to find the problem, it was behind building 300. IN the letter Mr. Truluck thanked Mr. Bowles.

Mayor and Council – Councilmember Wendelken passed out golf shop & grille totals for March & April 2016 and discussed the totals. Resident Al Hicks, 511 Lakeview Dr, spoke and told Council we are running the grille backwards. Councilmember Wendelken wants to make it profitable and make money. Mr. Hicks said it is a marketing thing, he talked about the budget and Mr. Harper, the previous owner; he also met with company that sold grass to Mr. Harper, and he will have a report for Seth Zeigler on the findings. Mr. Hicks wants to see the city get outside of box with the golf course. He asked outside of the negative, does

Council see what the golf course brings to the community. Mr. Payton Moxley said people don't know there is a grille at the golf course and he has never seen advertising for our golf course. Mrs. Simmons said we have ads in Effingham Magazine and Effingham Sports Magazine. Mr. Moxley wanted to thank Councilmembers Dasher, Ricker and Browher for visiting to the golf course.
